## Contending theories on international relations

POL-10780-20082, Vertiefungsseminar, SWS: 2, ECTS: 6, Max. Teilnehmer: 20

**Dozent:** Benjamin Schreer

**Termine:** Mo 18:00 - 20:00 wöchentlich Raum D 430

**Kommentar:** This course on international relations theory has two main aims. The first goal is to make students familiar with the variety of different theoretical approaches to international relations such as realism, liberalism, and constructivism. The second goal is to apply these contending theories to 'real world' events.

Such an approach reveals to students the core assumptions, differences, and similarities of the various schools of thought on international relations. It also provides students with the ability to understand and participate in the scholarly discourse on international relations. Finally, students get a sense of the 'hyperpluralism' of the field and the need to tolerate different approaches in explaining the very same event.

This course requires extensive reading, regular attendance as well as active participation in order to succeed. In addition to preparation for each class, students will have to do a presentation and will have to submit an essay of around 3,500 words on issues pertaining to the focus of this seminar.

## Interest Groups in Europe

**Kommentar:** The course will assess the explanatory potential of the literature on interest groups in Europe for the following questions:

What entails the broad category interest groups? Which role do interest groups play in the European multi-level system? Which rules govern the relation between interest groups and the European institutions? Which chances of access and how much power do they have? Which action strategies do they choose?

During the first part the course will proceed with a critical assessment of the theoretical and empirical literature in interest groups in Europe. We will then organize an excursion to Brussels where we will meet a number of representatives of European interest groups and European institutions. The course participants will have to actively prepare this excursion and chair selected meetings.

## Organisational Pathologies of United Nations Transitional Administrations

**Kommentar:** A United Nations Transitional Administration faces extreme challenges and responsibilities: It is confronted with post-conflict hostility, low human capacity for reconstruction, and poor local infrastructure, and involved in a vast range of military and civilian tasks, with only few institutionalized knowledge available. In addition, there are significant institutional constraints, particularly on resources and recruiting, as well as political obligations. These conditions make United Nations transitional administrations (UNTA) a precarious venture, prone to develop organizational pathologies.

The course's main goal is to instruct students in analyzing emerging pathologies of UNIA and in giving recommendations for coping by putting organizational studies concepts to good use.

The seminar is structured in three parts: First, students are introduced to the historical and institutional context of UNTA and their operational phases. Second, the discussion of different theoretical frameworks on organizational pathologies and on coping strategies provides a theoretical toolbox for the analysis of UNTA performance. Third, the analytical concepts are applied to empirical reconstructions of cases of transitional administration.

**Kommentar:** Internationale Verwaltungen wie das UN-Sekretariat, die Europäische Kommission oder die WTO galten lange Zeit als Prototypen eines starr-regelorientierten „international civil service“. Erst in den letzten Jahren wurden dem New Public Management entnommene Konzepte wie Outputsteuerung, ergebnisbezogene Rechenschaftspflichten und Zielvereinbarungen in den Bereichen des Personal- und Finanzmanagements eingeführt.

Im Kurs werden diese wesentlichen Konzepte sowie Möglichkeiten und Grenzen von Performance Management in internationalen Organisationen erarbeitet. Die Studenten sind nach einer Einführungsveranstaltung angehalten ein Problem bzw. eine Fragestellung auf Grundlage der gesichteten Literatur zu identifizieren. In einer folgenden Doppelstunde sollen Problemlösungsstrategien diskutiert werden, mit denen die Studenten ihre Fragestellung konzeptionell und/oder empirisch aufarbeiten können. Die Studenten haben dann bis Mitte Februar Zeit ihre Gruppenarbeit abzuschließen und eine Präsentation ihrer Ergebnisse vorzubereiten.

Für Ende Februar ist eine zweitägige Blockveranstaltung geplant, in der die Studenten ihre Projektarbeiten vorstellen. Herr Miguel I. Figuerola, Direktor der Human Resource Division der World Trade Organisation (WTO) wird die Projektarbeiten auf ihre Machbarkeit bzw. Plausibilität hin überprüfen („Reality-Check“). Daraufhin sollen in einer Gruppenarbeitsphase zusätzliche/alternative Lösungsansätze erarbeitet werden, die die Studenten in den Abschlussbericht ihrer Projektarbeit einpflegen.

**Kommentar:** With regard to the EU enlargement, many observers have described the advantages and disadvantages of the accession of up to 15 new members and the related political and economic changes. In this seminar the focus will be placed on the development of legislative decision-making processes in the EU before and after eastern enlargement.

It is assumed in political science that intergovernmental negotiations will become more complex in view of the increasing number of states and interests. The seminar aims to present decision-making scenarios for individual policy areas in order to anticipate and model future developments in the EU. The goal is to determine whether certain conflict lines have been aggravated and existing voting coalitions transformed. Emphasis will also be placed on the impact of the EU enlargement on individual policy areas such as agrarian policy, trade policy, consumer protection policy, and fisheries.

Students are expected to have basic knowledge of the political system of the EU and EU decision-making processes.

The seminar is in bloc format. A preliminary discussion will be held on 31 October.

### Strategic Studies

**Kommentar:** Why is military power used in world politics? Why do states go to war? What is the role of armed force in today's conflicts? These are some of the questions this module will address.

Strategic studies is a subfield of international relations, dealing with the use of military power to serve the ends of politics. The main goal of the course is to provide students with an in-depth understanding about contemporary strategy in both theory and practice.

The course is divided into three main parts. Part A deals with the essentials of strategic theory. What is the meaning of strategy? How can strategy be understood? Part B focuses on the evolution of both strategic thought and warfare from the nineteenth century to the end of the Cold War. Who were the defining strategic thinkers? What were the most crucial developments influencing the evolution of modern strategy? Part C discusses contemporary challenges for modern strategy. Is major war obsolete? Has strategy lost its relevance in the face of non-traditional security challenges? Can Western democracies prevail in counter-insurgency campaigns?

## Peace and Conflict

**Kommentar:** An important subfield of International Relations is the study of international and intrastate militarized disputes. Several theories and empirical findings offer a variety of reasons why states and societal groups get involved in armed conflict. The seminar will provide a survey of the most current research areas in the field.

We will verify the explanatory power of various theoretical approaches with empirical evidence. To do so we will inspect up-to-date research results but also will apply the theories to selected case studies.

An additional goal of the seminar is for the students to learn how to write academic papers and its related techniques. Besides two oral presentations and regular attendance, the course requirements are various written assignments and a final paper.
